



SERVICES AGREEMENT

Effective Date: Feb 28, 2026

This The Healers Club Services Agreement (“Agreement”) is entered into by and between The Healers Club (“we,” “us,” or “our”), located in New Jersey, USA, and you (“Client,” “you,” or “your”), collectively referred to as the “Parties.”

1. Services Provided

The Healers Club provides spiritual healing, mentorship, and membership services (“Services”), including but not limited to:

- Entity clearing and spiritual protection
- Energy healing and chakra balancing
- Akashic record guidance
- Live channeled sessions and collective readings
- Spiritual gift amplification and mentorship
- Group healing retreats and crystal healing
- Membership tiers: Collective, Soul Tribe (Standard), and Mentorship

All specific session details, schedules, deliverables, timelines, and pricing (“Service Description”) are outlined in your invoice, membership confirmation, or booking confirmation (“Statement of Work” or “SOW”).

2. Payment Terms

- a. Payment Due: Unless otherwise specified in the SOW, full payment is required in advance before services begin. Memberships require payment at the start of each billing cycle.
 - i. Mini Reading: \$70
 - ii. Tarot Reading and Guidance: \$350
 - iii. Full Healing: \$550
 - iv. Memberships: Collective (\$10/month), Soul Tribe (\$30/month), Mentorship (\$50/month)
- b. Deposits: Larger packages or retreats may require a non-refundable deposit (50% of total), with balance due prior to session delivery.

- c. Late Payments: Overdue payments incur a 1.5% monthly late fee. Services may be suspended, and access revoked until paid. Unpaid accounts may be sent to collections.
- d. Refunds: No refunds for completed sessions or accessed membership content. Memberships are non-refundable after 7-day trial (Collective only). Cancellations within 24 hours of booking may receive partial credit.
- e. Payment Methods: Credit/debit card, PayPal, or bank transfer via secure checkout. All transactions in EST timezone.

3. Client Responsibilities

- a. You authorize The Healers Club to access necessary platforms (Zoom, member portal) for service delivery.
- b. You confirm all provided information (personal details, intentions) is accurate. You warrant ownership of any submitted materials.
- c. Preparation: Arrive on time, in a quiet space, hydrated, with stated intentions. Heavy meals/alcohol 24 hours prior may affect outcomes.
- d. You agree to indemnify The Healers Club against claims from your materials, actions, or service misuse.

4. Scope Changes & Additional Work

- a. Services beyond SOW scope (extra sessions, custom readings) billed at full price as stated on the website..
- b. Cancellations/rescheduling within 24 hours incur full fee. No-shows forfeit payment.

5. Intellectual Property & Confidentiality

- a. Session recordings, channeled materials, and content remain The Healers Club property until full payment. Unauthorized sharing violates this Agreement.
- b. Client information kept strictly confidential. Channeled insights may be generalized for group settings.

6. Ownership Transfer

Full ownership of personal session deliverables transfers upon final payment.
Membership access ends at term conclusion.

7. Disclaimers & Limitation of Liability

- b. No Guarantees: Results vary by individual energy/receptivity. No specific outcomes promised.
- c. Limitation: Maximum liability equals fees paid. No consequential/indirect damages.

8. Termination

- a. Either party may terminate with written notice. Outstanding payments due immediately.
- b. Breach allows immediate termination without refund.

9. Governing Law

Governed by New Jersey, USA state law and United States federal law. Disputes resolved exclusively in the state or federal courts located in New Jersey, USA. EST timezone applies.

10. Entire Agreement

This constitutes the full agreement. Amendments must be written/signed. Electronic signatures binding.
